



# Fees Sheet Tiny Toes Childcare

## Fees with effect from 1<sup>st</sup> September 2017

Tiny Toes Childcare is open five days a week (Monday-Friday) and is able to provide care from 8:00 to 18:00. Parents can choose between term time only and an extended year (50 weeks). In addition, for primary school aged children we run holiday play schemes.

### Registration Fees:

There is no fee to register an interest in using the service, however we cannot accept a booking until we are in receipt of one month's fee in advance; this does not apply to those using only their EEF funded hours.

### Tiny Toes Childcare Fees:

### Fees including Early Education Funding.

The current Early Education Funding (EEF) is applicable to the majority of children, commencing the term after their third birthday. If you are eligible for the EEF, it means that your child is entitled to 15 hours free care each per week, for 38 weeks (term time). The 15 hours can be used between the hours of 8am and 6pm and a maximum of 10 hours can be applied to each day or 15 hrs over 2 days. You can only claim for 15 hours in total, across two providers. You are not able to claim EEF retrospectively and you will need to provide proof of your child's date of birth. Hours in addition to grant funded hours, or where the funding is restricted, will be charged at the usual rates. EEF is not available at times outside of the school terms dates i.e- during school holidays.

Please bring a packed lunch if children will be in the setting between 12.00pm and 1.00pm.

### Meals

- At the lunchtime session (12-12:30), children are required to bring their own packed lunches.
- A healthy snack will be provided during the morning, afternoon and evening core sessions.
- Breakfast will be provided during the breakfast session from 8.00am – 8.30am.

### Ad-hoc hours

- We offer a very limited service to those who may need to book a place or extend a booked session at short notice, however we cannot guarantee a space will be available. A 50p surcharge will be added to each hour booked at short notice/adhoc hours.
- If you drop or collect 0-10 minutes late or early you will be charged £1.00. If you exceed 10 minutes you will be charged the full hourly price for adhoc hours.

### Other Costs

- Charges for trips and other optional activities may apply and you will be advised prior to the event.

### Holidays

- Children attending the full year may be eligible for a discount on planned holidays where your child will not be attending nursery up to a maximum of 10 days depending on of your normal booking pattern pro rata- please speak to the admin office. There is no unpaid holiday for term time only children.

**Please note that 1 calendar month's written notice is required for session changes, or to withdraw a child from the nursery, or to reduce the number of sessions attended. This notice is not required for solely EEF funded sessions. Once a booking has been made you will be required to pay for those hours, even if you child does not attend.**

**In case of circumstances where a child will be absent for a prolonged periods, please speak to a member staff to discuss the options available. There is an administration charge of £10 payable for any cheques paid to us which fail to clear. All invoices must be settled by the 10<sup>th</sup> of the month otherwise an administration fee equal to 5% of the invoice value will be charged. If you have difficulties paying an invoice please contact us to discuss payment options.**
